Strategy Description

- ➤ The Trium Epynt Macro Fund pursues a traditional thematic approach to investing, with a focus on identifying and monetising major macroeconomic and geopolitical trends.
- ➤ The Portfolio Manager has the flexibility to invest across fixed income, foreign exchange, commodities and equities, with a global remit encompassing both developed and liquid emerging markets.
- ➤ The Fund aims to achieve a 6-10% annualised return, independent of market environment, with a volatility of 6-10%.

Portfolio Manager's commentary

- ➤ The Fund returned 1.0% in January, with gains from fixed income and commodity strategies outweighing losses in FX.
- ▶ Stock markets weathered a wide-ranging policy brainstorm from newly inaugurated President Trump, and a 'bombshell' moment in tech, to make a strong start to the year.
- ▶ Trump wasted no time in threatening various trade tariffs against friends and foes alike, injecting volatility into currency markets. When all was said and done, the broad Dollar index finished the month close to unchanged.
- ➤ The Fund's Yuan short was a drag on performance, amid suggestions that the US will initially go easier on China relative to the eye-watering proposals mooted during the election campaign.
- ▶ The big news in equities was the release of the DeepSeek LLM, which left investors scrambling to swot up on the implications of a popular new challenger powered by less advanced (and significantly cheaper) chips.
- ➤ Treasury yields surged higher towards 5%, on the familiar narrative of continued economic resilience and inflation concerns, before falling back to around 4.5% as investors sought sanctuary from the tech carnage.
- ▶ Tactical trading in UK rates made a useful contribution. With the market pricing just 32bp of cuts by the end of 2025 (vs the BoE's most recent estimate of 100bp) we saw good asymmetry in positioning for further cuts, with one 25bp reduction a 'given'.
- ▶ We remain positioned for higher yields in Japan and benefitted as the BoJ hiked rates and indicated that there will be more to come. At the Fund level, however, we are net long bonds for first time this side of Covid* (see forthcoming commentary for further explanation).
- ▶ Gold was the top performer for the Fund, having scaled exposure back up early in the month. Further gains came from longs in silver, platinum and carbon trading, while uranium was a detractor as participants factored in the prospect of lower Al-related energy demand.
- ▶ The Fund's small residual position in the convertible bonds of a Bitcoin holding company made a positive contribution. We remain cautious, with the release of the Trump family meme coins raising eyebrows among those in the industry who condemned the move as a setback for the campaign to establish crypto as legitimate institutional asset class.
- ➤ Smaller losses were incurred on exposure to Chinese equity indices, which were an outlier in January on lacklustre data and tariff speculation. We took advantage of the sell-off to scale our position back up.





MTD P&L Attribution (% NAV)




Asset Class Exposure (% Gross VaR)




Portfolio Themes (% Gross VaR)




Top 10 Positions (% Gross VaR)



Position Exposure (% NAV)*




FX Exposure (% NAV)*

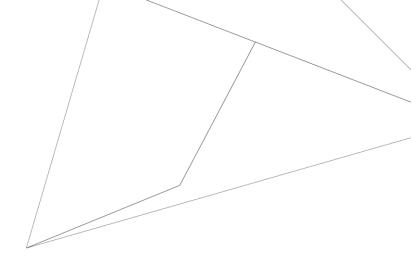
