Strategy Description

- ▶ The Fund strategically diversifies across an array of uncorrelated strategies, each managed by Trium's experienced investment teams, combining them into a risk managed, capitalefficient, portfolio aiming for uncorrelated performance whilst protecting investors' capital.
- ▶ Targets Cash plus 5% annualized net return, < 5% annualized volatility, and average zero beta to the MSCI ACWI Index over a market cycle. The underlying strategies span: Relative Value, Global Macro, Equity Market Neutral and Event Driven.
- ▶ The Head of Multi-Strategy is responsible for Portfolio Construction, with oversight provided by the Trium Multi-Strategy Committee. Independent Risk Management is undertaken by the Trium Risk team, headed by Marina Tsikoura (Chief Risk Officer).

Monthly Commentary

The Trium Multi-Strategy UCITS was up +1.5% in June, taking H1 2025 returns to +6.4% (E USD), so comfortably on track for the Fund's Cash +5% target return, again this year. Portfolio construction tilts were implemented as at the beginning of June, with allocations increased in four of our nine strategies:

- ▶ Quantitative EMN Consistent strong performance over the past 12 years with a diversified approach and low cross-correlation to our discretionary EMN strategies.
- ▶ Global Macro Thematic: Has underperformed YTD but has a propensity to perform strongly after flat performance periods. The timing was prescient, as the strategy performed very strongly in June.
- ▶ Discretionary EMN (ESG-focus) Has had a small weighting and was increased somewhat as we see a less difficult opportunity set ahead for the strategy.
- ▶ Convertible Bond Arbitrage we expect a good calendar of new issuance, and the PM team are finding idiosyncratic arbitrage opportunities.

The Fund ended the month with an allocation leverage of 166.6%

Summary

The Fund benefited from the additional weighting tilted towards our Global Macro (Thematic) strategy, which had a particularly strong performance. While our Discretionary EMN and Quant EMN strategies, which also received higher allocations, provided meaningful contribution. These two strategies contributed around half of the Fund's returns in June. Meanwhile, we saw meaningful contributions from our other discretionary Macro (Trading) strategy as well as from our allocations to discretionary EMN and to Merger Arbitrage, and none of our other strategies were down.

Global Macro

Our thematic global macro strategy had well-diversified gains. Returns were led by Fixed Income as the strategy benefited from a move lower in short-term Hong Kong Dollar rates, before booking profits. Their tactical long in US 30-year Treasuries was also profitable, and this was closed out after hitting its target. In FX, gains came from the strategy's long in the Brazilian Real amid the backdrop of a weaker Dollar (DXY -2.5%). The strategy also benefited from long commodity positions, notably in Uranium, which appreciated due to geopolitical factors and as the US announced supportive measures toward nuclear power. The strategy's largest detractor was a long EM government bond position. (Continued Overleaf)

Monthly Commentary (Continued)

Our trading-oriented discretionary global macro strategy performed relatively well given its more defensive macro views. Although risk markets continued to rally in June, longs in fixed income, shorts in the US Dollar, and receivers in EM rates more than offset losses on credit index shorts.

Event Driven

Our hard catalyst Merger Arbitrage-focused strategy had a modestly positive month. The Portfolio Manager is taking a low-risk approach, focusing on shorter-dated events with catalysts that are not market-correlated. June contributors were led by a few increased offers and competing bids across the globe (including Australia, Italy, Japan, and the US). These deals were primarily smaller-than-usual deals in the universe where the investment team had identified an outsized return profile. Even though each of these positions is relatively small, they delivered outsized returns relative to what the team viewed as limited risk. The only notable detractor was a small short position in a M&A target that incurred a loss when the deal closed.

Equity Market Neutral

Our Discretionary EMN strategies produced the largest returns within our EMN cluster of strategies in June. Thet took advantage of high dispersion in their sectors of focus, driven by volatility in macro and regulatory environment, to generate alpha from idiosyncratic long stock positions which outperformed short positions, typically in the same/similar industries, selected to seek to dampen down factor risk as well as to achieve close to zero beta at portfolio level.

Our Quantitative EMN strategy made another strong positive contribution to the Fund in June, to conclude a very strong H1 for the strategy. It has been up every month and YTD is annualising in the midteens. Notably, as well as having a very low correlation to markets in its own right, its cross-correlation to our discretionary EMN strategies remains close to zero, providing valuable diversification benefits. The top-performing model group was News Arbitrage, which benefited from the market gradually gravitating towards stocks that announced relevant information. Stock Sentiment and Quantamental also had a good month - Value, Growth and Size characteristics were favoured, while Quality characteristics were penalised. Variable Bias and Statistical Arbitrage also delivered positive returns.

Our discretionary, catalyst-driven EMN strategy performed positively, particularly helped by the good performance of a high-conviction US-

listed consumer discretionary stock position.

Relative Value

Our Systematic Macro RV strategy made another positive contribution. Its profits came mainly in FX, where it benefited from the continued depreciation of the Dollar against G10 peers, especially AUD and SEK, and from capturing dislocations between FX and rates.

Although our Convertible Bond Arbitrage strategy was close to flat on the month, the Portfolio Manager is positive about the outlook for the strategy. The New issue calendar is strong. June saw \$17.2 billion in new issuance in the U.S., led by GameStop (0% 2032, \$2.7 billion) and Cloudflare (0% 2032). Asia saw \$4.9Bn of new issuance with Ping An (0% 2030, \$1.5 billion) the standout deal, Europe added a more modest €1.2 billion in new deals. Credit markets continue to be firm while high levels of single-stock volatility provide a supportive backdrop.

Outlook

The nine strategies are proving to be resilient in their own right. Each of them is successfully implementing an uncorrelated investment process and the Fund is benefiting from the very low levels of cross-correlation which the differentiated strategies, understandably, have to each other. This allows the Multi-Strategy team to employ allocation leverage which has been successful in boosting returns while incurring minimal incremental fund-level volatility.

The Fund continues to be well on track to deliver its annual performance target of at least Cash +5% again this year.

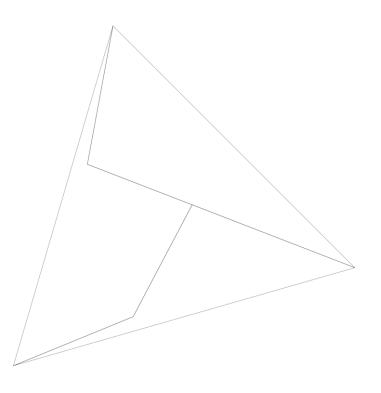
